# MINUTES OF THE MEETING OF SYNOD HELD IN MELBOURNE 18 – 21 NOVEMBER 2023

All activities, except for the opening service, were held at Box Hill Town Hall, 1022 Whitehorse Road, Box Hill.

# **23.1 SATURDAY 18 NOVEMBER 2023**

## 23.1.1 OPENING SERVICE

The Synod opened at 10:00am with a Service of Worship at the Salvation Army Hall, 1010 Whitehorse Road, Box Hill.

The worship began with a Welcome to Country by Wurundjeri Elder Bill Nicholson of the Wurundjeri Woi Wurrung Cultural Heritage Aboriginal Corporation.

The worship was led by the Moderator, with Brooke Prentis, Aboriginal Christian Leader, international speaker, writer, educator, and poet, preaching. The theme of the Synod meeting and the opening service was 'We belong to the day' (1 Thessalonians 5:8).

#### 23.1.2 COMMENCEMENT OF THE MEETING

The Moderator occupied the chair at 12:00pm and welcomed members.

#### 23.1.2.1 WELCOME

The Moderator welcomed Rev Sharon Hollis, President of the National Assembly, and Colleen Geyer, General Secretary of the National Assembly.

The Moderator welcomed Brooke Prentis, who preached at the opening worship and would provide a theological reflection for each day of the meeting.

The Moderator welcomed Andrew Johnson, Act2 Project Lead, who joined the meeting as a visitor for 18-19 November.


The Moderator reminded members that the meeting was a safe space and requested members to read the safe space statement on the meeting app. The Moderator introduced the Safe Meeting Contacts, Rev Lavingi Tupou and Rev Sandy Brodine.

The Moderator introduced the meeting chaplains, Rev Deacon Wendy Elson, Rev Ray Gormann, and Rev Gospel Ralte.

The General Secretary, Rev Dr Mark Lawrence, indicated that the Synod Roll would be confirmed at 3:30pm on Sunday 19 November 2023 and reminded members to advise any changes in the roll to the Associate General Secretary, Isabel Thomas Dobson, as soon as possible.

#### 23.1.3 OPENING BUSINESS

## 23.1.3.1 THEOLOGICAL ORIENTATION

Rev Assoc Prof Geoff Thompson, Coordinator of Theological Studies at Pilgrim Theological College, presented a theological orientation for the Synod meeting on interrelated Councils and discerning the will of God.

## 23.1.4 SYNOD MEETING PLANNING COMMITTEE REPORT (C1.4)

The Associate General Secretary, Isabel Thomas Dobson, assumed the General Secretary's chair.

The Moderator introduced the General Secretary, Rev Dr Mark Lawrence and Rev Sue Clarkson, Convenor of the Business Committee, which is now a sub-committee of the Synod Meeting Planning Committee (SMPC). Sue spoke to a written report on behalf of the Moderator, who is Chairperson of the SMPC.

Sue expressed appreciation on behalf of the SMPC for the generous commitment of time and resources by those who provide support for the Synod meeting in various volunteer roles, including the provision of audio/visual and hospitality support.

Sue also thanked SMPC members and Kathryn D'Alessandro, Sarah Manase, Charis Fraser, Debra Penaluna, Mandy Ratnam and Lynda Nel for their efforts in the planning and support of the Synod meeting.

## 23.1.5 SYNOD 2023 PROCEDURES

#### 23.1.6 SYNOD STANDING COMMITTEE (REPORT C1)

The General Secretary, Rev Dr Mark Lawrence, spoke to a written report.

The General Secretary thanked Rev David Fotheringham for his leadership and guidance of the Synod Standing Committee as Moderator, and Kathryn D'Alessandro for her administrative support and assistance to the Committee.

#### 23.1.6.1 Synod Standing Committee By-Laws (Proposal 14 – revision of Proposal 5)

Rev Dr Mark Lawrence and Rev Denise Liersch introduced this proposal on behalf of the Synod Standing Committee.

The Synod resolved by consensus:

To approve the revisions to the Synod Standing Committee By-Laws, as outlined in the Appendices attached to this proposal rationale, to take effect from the conclusion of the November 2023 Synod Meeting.

The General Secretary resumed the General Secretary's chair.

#### 23.1.7 **MODERATOR'S REPORT**

He also thanked Rev David Fotheringham, Isabel Thomas Dobson, Kathryn D'Alessandro, Clare Boyd-Macrae (who retired in April 2023), Charis Fraser, and the Office of the General Secretary team for their support and dedication.

The General Secretary resumed the General Secretary's chair.

# 23.1.15 MODERATOR-ELECT NOMINATING COMMITTEE (REPORT D5)

Rev Salesi Faupula left the meeting prior to this matter commencing.

The Moderator welcomed Rev Sue Withers, Convenor, Moderator-elect Nominating Committee, who is a former Moderator (a practice within the Synod for the Convenor of the Committee). Sue spoke to a written report.

# 23.1.15.1 Moderator-elect Ballot Threshold (Proposal 12)

The Associate General Secretary, Isabel Thomas Dobson, assumed the General Secretary's chair.

The General Secretary, Rev Dr Mark Lawrence, and Rev Denise Liersch introduced the proposal on behalf of the Synod Standing Committee.

The Synod resolved by consensus:

That the threshold for the majority ballot for the Moderator-elect continue to be 66%, in accordance with Synod resolution 98.5.2.2.

The General Secretary resumed the General Secretary's chair.

#### 23.1.16 MODERATOR-ELECT NOMINEE PRESENTATION

Rev Salesi Faupula returned to the meeting.

The Moderator welcomed Rev Salesi Faupula to the stage for his address.

Salesi addressed the Synod.

The Moderator led the Synod in prayer for Salesi, his family and for the Synod members' discernment, and reminded members that the Ballot for Moderator-elect would open at 11:00am Sunday 19 November 2023.

## 23.1.17 THEOLOGICAL REFLECTOR AND CLOSE OF DAY

The Moderator welcomed Brooke Prentis who shared a theological reflection.

The Moderator closed the day with prayer and invited the Synod members to a 'welcome meal'.

# 23.2 SUNDAY 19 NOVEMBER 2023

#### 23.2.1 DEVOTIONS

The Moderator welcomed members to the meeting's second day. He gave an Acknowledgement of Country and introduced his chaplains, Rev Jinseon Park, and Rev Semisi Tauali'i, who led the daily devotions.

#### 23.2.2 BIBLE STUDY

The Moderator welcomed back Rev Associate Professor Robyn Whitaker who led a Bible study on the theme of "Past expectations / The Day of the Lord and taking the long view" (Isaiah 13:6-13 and Matthew 25:31-46).



#### 23.2.3 PROPOSALS

## 23.2.3.1 Ethical Procurement and Investment (Proposal 7)

Dr Paul Chandler, Chairperson, Ministry & Mission Committee, and Rev Duncan Macleod, Executive Officer, eLM, introduced this proposal. Dr Mark Zirnsak, Senior Social Justice Advocate, eLM, spoke to the proposal.

The Moderator welcomed guest speaker, Ramila Chanisheff, President of the Australian Uyghur Tangritagh Women's Association, who gave a presentation on Uyghur forced labour.

The Synod resolved by consensus:

In alignment with the vocation of the Church to be "an instrument through which Christ may work and bear witness to himself" (Basis of Union, para. 3):

- To lament that all parts of the Synod cannot avoid business transactions where the goods and services supplied will have involved serious human rights abuses, excessive environmental damage or other severe criminal activity in their production;
- b) To call on Synod Ministries & Operations, congregations, presbyteries, U Ethical, Uniting Vic.Tas, Uniting AgeWell and Uniting Church members:
  - i. to seek to deal with businesses that uphold ethical standards, including transparency in their ownership;
  - ii. to not invest in and to avoid purchases from businesses involved in on-going serious human rights abuses, excessive environmental damage and non-trivial criminal activity where there is a viable alternative supplier:
  - to not invest in and to avoid purchases from businesses that have been proven to have been involved in serious human rights abuses, excessive environmental damage and non-trivial criminal activity in the last five years, unless there is strong verification that the business has corrected its past practice and conducted meaningful remediation of its past wrong-doing; and
  - iv. to not have dealings with any business that has been established through criminal activity, or purchased with proceeds of crime, in the previous 20 years.

## 23.2.4 INTRODUCTION TO BALLOT 1 (MODERATOR-ELECT)

Rod Mummery, Returning Officer, introduced the ballot for Moderator-elect and explained the electronic ballot process.

Rod reminded members that the threshold required for the ballot is 66% and confirmed the ballot for Moderator-elect would close at 2:00pm on Sunday, 19 November 2023.

The Moderator led the Synod in prayer for the Moderator-elect nominee, and for the Synod as it entered a period of focused discernment.

The electronic ballot was opened.

## 23.2.5 ELECTIVE SESSIONS

The Synod members participated in a number of Elective sessions. Topics included:

- The Church and Reconciliation beyond the Referendum (Brooke Prentis);
- Reducing the influence of corporations selling harmful products in our democracy (by Dr Mark Zirnsak, eLM);

- A snakes and ladders board game designed for conversations re discrimination and participation, which can be linked to a range of issues in the disability inclusion area (by Rev Dr Deac Andy Calder, eLM);
- Congregations and Uniting partnering to enliven a community and confront injustice (by Uniting); and
- Experience the real-life challenges of people living in a remote village (by Mardi Lumsden, UnitingWorld).


# 23.2.10 INTRODUCTION TO WORKING GROUP 2 - FAITHFUL FUTURES PART 1 (REPORT D4)

#### 23.3.12 PROPOSALS

# 23.3.12.1 Reducing the harm of prohibited drugs towards a health-based approach (Proposal 23 – revision of Proposal 8)

Adrian Webber, General Manager – Alcohol and Other Drugs, Mental Health and Carer Services was associated for the business of this proposal.

Rev Alistair Macrae, Deputy Board Chairperson, Uniting Vic.Tas, and Dr Paul Chandler, Chairperson, Ministry & Mission Committee, and Adrian Webber, General Manager – Alcohol and Other Drugs, Mental Health and Carer Services, Uniting Vic.Tas, introduced this proposal.

Rev Dr Margaret Mayman, Facilitation Group member, spoke to the proposal.

The Synod resolved by consensus:

Recognising that substance abuse may cause enormous harm to individuals, families and communities and that the Church discourages use of illicit drugs:

- a) To call upon the Victorian and Tasmanian Governments to foster an open dialogue with the community on the most effective strategies to reduce the harm of illicit drugs.
- b) To affirm that alcohol and other drug-related policy in Victoria and Tasmania should reflect the following principles:
  - Dependency on illicit drugs is the result of complex interplay between psychosocial, developmental and environmental factors requiring a health and social response;
  - ii. The fundamental objective of drug policy should be to keep people safe and reduce the harm of use and provide pathways to wellness;
  - iii. While law enforcement actions to disrupt large scale supply of illicit drugs remain essential, drug possession for personal use should not be a crime and individual drug users should not be subjected to the criminal justice system for personal use;
  - iv. Policies should not stigmatise, marginalise or punish drug users;
  - v. Drug policy and treatment should reflect the best available evidence and resources should be allocated towards measures that are most effective.
- c) To support and advocate:
  - i. for greater funding in demand reduction and harm reduction strategies, including specialist alcohol and other drug treatment and harm reduction services, to support people who use drugs and to address harm to families and communities associated with illicit drug use, and
  - for the decriminalisation of possession and personal use of small amounts of illicit drugs.
- d) To write to the Premiers, Opposition Leaders, Attorneys General, Ministers for Health as well as Shadow Attorneys General and Shadow Ministers for Health in Victoria and Tasmania; to inform them of this resolution.

The Moderator led the Synod in prayer.

# 23.3.12.2 Secure Work (Proposal 22 – revision of Proposal 9)

Dr Paul Chandler, Chairperson, Ministry & Mission Committee, and Rev Duncan Macleod, Executive Officer, eLM, introduced this proposal. Dr Mark Zirnsak, Senior Social Justice Advocate, eLM, spoke to the proposal.

Andrew Boatman, Facilitation Group member, spoke to the proposal.

The Synod resolved by consensus:

In affirmation of the Uniting Church as Employer Principles and its theological underpinnings (Synod resolution 01.6.4.4), that provide a guide for the way all employed people should be treated:

- a) To confess with lament that we have not always lived up to the Uniting Church as Employer Principles, often despite our best endeavours;
- To call on all parts of the Synod, including its institutions and councils of the Church, to embrace and implement the Uniting Church as Employer Principles in their employment practices where they do not already do so;
- To publicly support all reasonable additional measures in law and practice that seek to create gender equity and eliminate sexual harassment in the workplace;
- d) To publicly support all reasonable measures in law and practice that ensure that people doing the same work at the same level for the same employer are paid the same and are given equivalent conditions;
- e) To call on the Commonwealth and State Governments to:
  - i. ensure the on-demand gig economy is not used by unethical employers to classify employees as independent contractors; and
  - ii. amend the existing law to establish collective bargaining rights for all people engaged in work through the gig economy;
- f) To call on the Commonwealth Government to establish a national industrial commission (or a Fair Work Commission jurisdiction) to:
  - regulate all work contracts regardless of the work status of those workers and regardless of how those workers were engaged including arrangements for the engagement of on-demand gig workers;
  - ii. hear and determine complaints concerning the unfair termination of work contracts for all workers, including those working in the gig economy; and
  - iii. issue orders to ensure supply chain accountability where workers, including on-demand gig workers, are engaged by subcontractors;
- g) To call on the Commonwealth Government to introduce, for people on temporary visas who have a meritorious claim of workplace exploitation, a short-term visa with work rights to enable them to stay in Australia while pursuing their claim; and
- h) To write to the Prime Minister, Minister for Employment and Workplace Relations, Shadow Minister for Employment and Workplace Relations, the Leader of the Opposition, the Leader of the Australian Greens, the Victorian Premier, Victorian Minister for Industrial Relations, Victorian Minister for Employment, the Victorian Leader of the Opposition, the Tasmanian Premier, the Tasmanian Leader of the Opposition, and the Tasmanian Leader of the Greens to inform them of the above resolution.

The Moderator's chaplain, Rev Semisi Tauali'i, led the Synod in prayer.

# 23.4.7.1 Minute of Appreciation for Rev Ikani Vaitohi (Proposal 17)

The Moderator invited Isabel Thomas Dobson, Associate General Secretary, and Dr Paul Chandler, to present the Minute of Appreciation for Rev Ikani Vaitohi as Chairperson of the Synod Ministry and Mission Committee.

The Synod resolved by acclamation:

To give thanks to God for the Rev Ikani Vaitohi and his creative, inclusive, and inspiring leadership as Chairperson of the Synod's Ministry and Mission Committee (M&M) from June 2021 to June 2023.

The Rev Ikani Vaitohi was elected a member of M&M in August 2019. When Rev Graeme Harrison retired as inaugural Chairperson, Ikani was elected as Chairperson, beginning in that role in June 2021.

Ikani's keen commitment to and engagement with the Committee's areas of responsibility was clear to all Committee members. His enthusiasm, creativity, and commitment to encourage the Committee to assist the Church to engage with the Gospel, the community and to recognise how the Church itself must embrace a different future brought energy and focus to the M&M meetings.

This was particularly important and challenging as COVID required the Committee to meet remotely by videoconference.

Ikani's leadership of M&M and the extra associated meetings was in addition to his responsibilities as minister at the Belmont UC Congregation, and later, the Yarraville UC Congregation. The Church expresses its gratitude to those Congregations for their support of Ikani and for enabling his gifts to be shared with the wider Church.

A challenging period of III health meant that Ikani reluctantly took leave of absence from M&M in November 2022 and then resigned in June 2023. Ikani's contribution to M&M, though shorter than he or the Committee hoped, has been significant, and for that we give thanks to God for all that he offered as the Committee Chairperson during this period.

Rev Ikani Vaitohi responded.

The Moderator thanked Isabel, Paul and Ikani, and led the Synod in prayer for Ikani.

Rev Rachel Kronberger provided members with feedback from the Faithful Futures Project Working Groups discussion.

#### 23.4.10 PROPOSALS

# 23.4.10.1 Zero Emissions (Proposal 20 – Revision of Proposal 10)

Rev Jay Robinson, Facilitation Group member, and Dr Paul Chandler, Chairperson, Ministry & Mission Committee, introduced and spoke to this proposal.

The Synod resolved by formal majority:

a) As part of its response to climate change, to encourage all parts of the Synod, its institutions and other councils of the Church, to aim to reach zero emissions by 2040 at the latest, covering their Scope 1 (emissions directly generated e.g., gas) and Scope 2 (indirect emissions from electricity use) emissions.

The Synod resolved by consensus:

b) To express its gratitude for the support from governments for parts of the Synod and its institutions to reduce their emissions, acknowledging that the Synod would be far less able to reduce its emissions without government funding.

The Synod resolved by formal majority:

- c) To establish a Synod Emissions Reduction Fund (SERF/Fund):
  - i. with an initial funding of \$100,000 from the Synod;
  - ii. to be administered by the Synod Climate Action Taskforce (Taskforce); and
  - iii. request the Taskforce to report back to the next ordinary Synod meeting on the progress made and what further steps need to be taken, including financial resources required.
- d) To request that equipping Leadership for Mission develop Terms of Reference for the SERF, for consideration and approval by the Ministry & Mission and Property & Operations Committees, which shall include provisions that:
  - explore and scope the financial requirements needed to prioritise reaching zero emissions by 2040, at the latest;

- ii. describe how the funds will be directed for use within congregations and presbyteries to assist in the reduction of emissions in their operations and activities:
- iii. all parts of the Uniting Church in Victoria and Tasmania, including its members, institutions and councils of the Church be invited to make voluntary financial contributions to the Fund as they are able;
- iv. the Taskforce may encourage and assist congregations and presbyteries in making grant applications;
- v. the Taskforce shall prioritise support for applications that will have the most significant contribution to reducing emissions within the bounds of the Synod to reach as close to zero emissions by 2040 as possible; and
- vi. the Taskforce shall consider any other ethical issues related to the application of the Fund and other Synod resolutions and policies, such as suppliers being implicated in serious criminal activity, human rights abuses, or excessive environmental destruction.

The Synod resolved by consensus:

e) To request the General Secretary to ensure that the Synod's Scope 1 and 2 emissions, including emissions from its institutions, presbyteries and congregations, are measured at least every five years and report to the Synod on progress in relation to emissions reduction.

The Moderator led the Synod in prayer.

# 23.4.10.2 Future Leaders Task Group (Proposal 6)

The Associate General Secretary, Isabel Thomas Dobson, assumed the General Secretary's chair.

Rev Dr Mark Lawrence and Jacob Westley introduced this proposal on behalf of the Synod Standing Committee.

The Synod resolved by consensus:

To request the 2023 Synod meeting to extend the reporting date on the Future Leaders Task Group's work to the next ordinary Synod meeting;

 noting that consideration of succession planning for future leaders within the Church may be affected by the outcomes of the Faithful Futures Project and Act2 Project processes.

## 23.4.10.3 Synod 2025 Meeting Date (Proposal 11)

Rev Dr Mark Lawrence and Rev Denise Liersch introduced this proposal on behalf of the Synod Standing Committee.

The Synod resolved by consensus:

That the next ordinary Synod meeting be held between July 2025 and September 2025 (inclusive), with the timing to be confirmed by the Synod Standing Committee, upon a recommendation from the Synod Meeting Planning Committee.

# 23.4.10.4 Minute of Appreciation for Isabel Thomas Dobson (Proposal 18)

The Moderator invited Rev Dr Mark Lawrence and Lorraine Threlfall, to present the Minute of Appreciation for Isabel Thomas Dobson as Associate General Secretary.

## The Synod resolved by acclamation:

To record its deep appreciation and give thanks to God for the ministry of Isabel Thomas Dobson in the role of Associate General Secretary (from October 2013 to February 2024) and many other roles across the life of the Church.

Isabel Thomas Dobson's (Isabel) faithful and positive contribution to many parts of the Church has been profound, long lasting, and a wonderful expression of discipleship and commitment to Christ's mission in the world. All of the qualities that Isabel has brought to the Synod through her role as Associate General Secretary, and before that, as Moderator, including faithful and encouraging leadership; discerning observation; pastoral sensitivity; frank conversations; collaborator; history bearer; whole of Church perspectives; wise counsellor, shared discipleship; and so much more, have made a wonderful and deep contribution to the Synod and the wider Church.

As well ministering as Associate General Secretary, over the period of her serving in this role Isabel has served on, and resourced, a number of Synod and Assembly committees, forums, networks, etc. Isabel has provided significant leadership, often 'behind the scenes', to allow others to undertake their ministry and to share in God's mission in the world. These wider commitments include serving on the: Assembly Standing Committee – and a range of its task groups and related commitments; Victorian Council of Churches, and its Standing Committee; and membership of the World Methodist Council – and of a number of its committees.

Isabel has brought her background as an historian and educator into the Associate General Secretary role. Through both her awareness of events and themes that have shaped the Uniting Church's character, and her capacity to help others understand principles for the Church's approach to ministry and mission, Isabel has provided pastoral guidance and leadership for councils, ministers, and members of the Church to more faithfully live out their call to discipleship and following Christ's way of love and compassion. In all this, Isabel has consistently and realistically identified issues for councils, ministers, and members of the Church. Isabel has always done this in respectful ways, and sometimes in appropriately challenging ways — and has provided and collaborated with others to address these concerns and enhance the Church's commitment and capacity to share in ministry and mission.

Isabel's availability to respond to matters raised by a wide spectrum of people within the life of the Church is legendary. People are consistently appreciative of Isabel's wisdom and faithfulness as she engages with them in working through a range of matters. Sometimes these matters have been very complex and challenging, and sometimes people have just needed a reminder about a particular regulation, policy, and/or process to follow to address the matter. Isabel's calm and pastoral response to each enquiry is greatly appreciated. Isabel has consistently reminded the Church about good and due process. In the fullest sense of being pastoral, Isabel has been present for people and where appropriate, challenged assumptions and/or processes and invited those with whom she is engaging to always reflect on their agency and capacity to contribute positively to the Church's call and mission.

Many ministers, members, and councils of the Church have experienced Isabel's ongoing care, support, and wisdom when going though challenges or significant periods of change in their personal lives, congregation, or presbytery. With a breadth of knowledge and experience at hand, Isabel was always responsive to issues that were being addressed and available for advice to work through particular matters. Isabel consistently followed up with these people, supporting the congregation/presbytery whilst it was working through such challenges and changes. Isabel's pastoral care and 'being with' the congregation/presbytery in challenging and changing times was always appreciated.

As Associate General Secretary, Isabel has been a key contributor in 'interpreting' the Church to many Synod Ministries and Operations (SMO) staff, and 'interpreting' SMO to many members, committees, and councils of the Church. This contribution has been

deeply influential in building trust and appreciation across these parts of the Church and enhancing the Church's capacity as a whole to share in the call to be part of Christ's body in the world.

In a Minute of Appreciation that honours Isabel's ministry over the past decade, it is appropriate to highlight her deeply, deeply significant role in providing Church-wide leadership and support during the COVID-19 pandemic. As the Synod's Crisis Management Team Convenor, Isabel worked tirelessly to support the Synod committees and staff, presbyteries, and congregations, in responding to an unprecedented set of circumstances. Isabel's thoughtful, calm, and appropriately firm leadership was deeply appreciated throughout the 'COVID-years'. Her leadership and example encouraged others to have confidence that the Church could continue to undertake worship, witness, and service through this challenging period, and to do so in agile and responsive ways – even in the ever-changing and fluid environment that was daily confronting the Church and wider community.

Isabel's ministry of Associate General Secretary and the gifts and graces outlined above, emerge from a life-long commitment to discipleship founded upon a deep love and appreciation for the biblical narrative and faithfulness shaped by her formative years, and a deep commitment to Christian practices throughout her life. Isabel's spirituality and theological astuteness is profoundly apparent as she has undertaken the responsibilities of Associate General Secretary. Across the spectrum of these responsibilities from administrative tasks, to addressing significant concerns in life of the Church, through to strategic missional direction setting; Isabel's formation through biblical and theological reflection, and a personal commitment to spirituality and living out her personal and communal commitment to discipleship is ever-present. This is a model for Christian life and commitment that has positively impacted on many, many people within SMO, Synod committees, and across the councils and membership of the Church.

There is so much to thank Isabel and God for, for her gifts and graces, and for the nature and scope of the ministry and leadership that Isabel has offered to this Synod and the wider Church over many years of being called to ministry placements within the Church, and also for her commitment to the Uniting Church and ecumenical partners as a lay person throughout her life. The Church is exceedingly grateful for all that Isabel has offered in each of her placements and other commitments, and particularly, for her wise and faithful ministry as Associate General Secretary.

The Synod prays that as Isabel moves into retirement from active ministry, she will enjoy an enriching period of joy, hope, rest, and continuing service in ways that nourish her commitment to God's mission in the world through the way of Christ.
