#### MINUTES OF THE MEETING OF SYNOD HELD IN MELBOURNE

5 - 9 JULY 2019

All activities, except for the opening service, were held at Box Hill Town Hall, 1022 Whitehorse Road, Box Hill.

#### 19.1 FRIDAY 5 JULY 2019

# 19.1.1 OPENING SERVICE

The Synod opened at 7.30pm with a Service of Worship at St Michael's Uniting Church, cnr Colllins & Russell Street, Melbourne. The worship began with a Welcome to Country by Wurundjeri Elder, Aunty Georgina Nicholson and included the Installation of the Moderator, Rev Denise Liersch.

The theme of the service was Isaiah 43:19 'Behold I am doing a new thing; now it springs forth, do you not perceive it?' and the proclamation was based on the reading from Luke 7:36-50

# 19.2 SATURDAY 6 JULY 2019

#### 19.2.1 COMMENCEMENT



# 19.2.7.3 Confirmation of Minutes of Synod 2019

# 19.2.8.1 Additions and revision to Synod Standing Committee By-Laws

The General Secretary, Rev Dr Mark Lawrence, spoke to a proposal.

- (a) To approve the following revision of Standing Committee bylaw clause 5.1(c) (iii), deleting from its current wording all words after "Six members will be elected at each ordinary meeting of the Synod for a period of two ordinary meetings of the Synod."
  - (i.e. deleting the words 'except in the cases of the first Synod at which these By-Laws apply, in this election, when 12 persons will be elected, the six persons who receive the most support through the voting system that is used will be elected for the period of two ordinary meetings of the Synod; and the next six successful candidates will be elected until the next ordinary meeting of the Synod'.
- (b) To approve the following additional clauses to section 6 of the Standing Committee bylaws:
  - 6.5 (a)
- (i) If a casual vacancy occurs 12 months or more after the previous ordinary Synod meeting, the vacancy will not be filled until, if appropriate (see 6.5(b) below), a Synod member is elected at the next scheduled ordinary Synod meeting; however
- (ii) If, as a result of the casual vacancy, the number of lay people as members of Standing Committee is fewer than the number of ordained people (Reg 3.7.4.1(b)), the Standing Committee will be authorised to appoint another lay person to the Standing Committee who was a member of the previous Synod until the next ordinary Synod meeting.
- (b) If the casual vacancy results from a Standing Committee member elected for a term that continues beyond the next scheduled ordinary Synod meeting, the Synod shall elect a Standing Committee member to serve from that Synod meeting to the next ordinary Synod meeting.

## 19.2.8.2 Change in Synod election practices

The General Secretary, Rev Dr Mark Lawrence, spoke to a proposal.

The Synod resolved by consensus:

- (a) To authorise the Synod Standing Committee to make appointments, or delegate the responsibility to make appointments, to the following committees/bodies:
  - Australian Church Women (Vic Unit);
  - Council for Chaplaincies in Tertiary Institutions;
  - National Council of Women;
  - Synod Business Committee Chairperson and members;
  - Synod Creative Design Team Chairperson and members;
  - Terms of Placements Committee Chairperson and members;
  - Victorian Council of Churches:
  - Tasmanian Council of Churches; and
  - World Day of Prayer Committee.
- (b) To authorise, where needed, the Standing Committee to approve amendments to committee/body By-Laws or Terms of Reference to reflect any changes needed in appointment arrangements resulting from clause (a) above.

# 19.2.8.3 Appointment of Convenor for Moderator Nominating Committee

The General Secretary, Rev Dr Mark Lawrence, spoke to a proposal.

The Synod resolved by consensus:

To appoint Dan Wootton as the Convenor of the Moderator Nominating Committee for the Moderator who will commence her/his term at the 2022 Synod meeting.

# 19.2.10.1 Minute of Appreciation: Rev Sharon Hollis as Moderator 2016-2019

Rev Ann Perrin and Joy Han spoke to a proposal and Rev Sharon Hollis responded. A presentation was made to the Ex Moderator.

The Synod resolved by acclamation:

To record its appreciation for the ministry of Rev Sharon Hollis as Moderator of the Synod of Victoria and Tasmania from 3 June 2016 to 5 July 2019; and

To give thanks to God for Sharon's faithful sharing of her many gifts in service to the Church and to the wider community, including her gracious, courageous and compassionate leadership in living out Jesus Christ's call to follow him and participate in his ministry of reconciliation and renewal.

Sharon's pastoral heart shines through all the work she has undertaken. She has shown the depth of her concern for people and their wellbeing wherever she meets them in her extensive travels across Victoria and Tasmania or in difficult situations arising in the life of our Church. She has encouraged reflection and held space for prayer and lament, taking time to build relationships as she journeys with individuals and their communities in both their joys and sorrows.

Sharon has brought her whole self to the role of Moderator and her whole life to her ministry including her experiences of love and loss. She has not shied away from allowing us glimpses of her vulnerable self, especially in her commitment to supporting mental health awareness and destigmatising mental illness and suicide.

Sharon has been an excellent chairperson of Synod Standing Committee, and various other committees and groupings. She is diligent and thorough in her preparation, and plans the shape of the meeting looking for the best outcomes for peoples' time. She has been non-reactive and worked with focus and intention. The strength of her ability to facilitate discernment is attested to by members of committees and groups throughout the Church.

Sharon has shared her focused and creative leadership as the Synod implements the outcomes of the Major Strategic Review. Her contribution to this process has been cuttingedge, provoking us to think in new ways about our life as the Church. She brings the Synod Vision and Mission Principles to life by sharing her conviction in their importance for shaping our life together.

Sharon has generously shared her passion for the particularities of how we understand ourselves and order our ministry and mission as the Uniting Church in Victoria and Tasmania. She has expressed this through her commitment to our walking together as First and Second Peoples, ecumenical and interfaith dialogue, her work with the Victorian Government's Multi Faith Advisory Group and our shared discernment of areas in the Church where we require reform. Her public leadership in the wider community, and indeed throughout the Church, has been deeply valued by the many organisations with which she has engaged, including U Ethical, Uniting AgeWell, Uniting VicTas, Uniting Housing, and the UCA associated Schools and University Colleges.

Sharon has advocated boldly for justice in the Church and the wider community. She has listened compassionately to people's sharing of their experiences of injustice and has stood alongside them to speak and act prophetically. Sharon has spurred us on to pay greater attention to systemic inequality and to respond by living out the call to renewal in the power and hope of Christ. By readily calling out the state of affairs with grace and, as required, great humour, Sharon has comforted many and encouraged them as they persevere in making their witness heard.

We give thanks for Sharon's faithful service as Moderator and for her continuing devotion to Christ, her ministry and her leadership that has challenged and encouraged us to remember that Christ constitutes, rules and renews his disciples as his Church.



  - (i) ensuring that the NDIS Quality and Safeguards Commission has sufficient jurisdiction and resources to provide thorough oversight and regulation of disability and mental health services operating under the NDIS to prevent abuse, neglect and other mistreatment of people with disabilities. While these safeguards must prioritise the health and safety of people with disability, the approach should be designed to minimise unnecessary regulatory burden experienced by providers;
  - (ii) providing a dedicated team of staff within the NDIS Quality and Safeguards Commission to investigate preventable deaths that occur when people with disabilities are in the care of service providers within the NDIS;
  - (iii) putting in place robust systems to screen all individuals that provide services to people with disabilities under the NDIS;
  - (iv) maintaining and enhancing Community Visitors' and Official Visitors' programs, across states, to provide a vital monitoring and advocacy role for people with disabilities.
- (b) To write to the Prime Minister and the Leader of the Opposition to inform them of this resolution.

# 19.3.12.2 Reform of the Community Development Program

Lindsay Oates, Deputy Chairperson, Ministry & Mission Committee and Dr Mark Zirnsak, Senior Social Justice Advocate, eLM, spoke to a proposal.

The Synod resolved by consensus:

(a) To acknowledge the discriminatory nature of the Community Development Program, which sees higher requirements placed mainly on First Australians seeking employment in remote areas than on people elsewhere in Australia;

- (b) To call on the Commonwealth Government to work with First People organisations to develop a new program to assist First People, in remote Australia who are looking for work, such as the proposal put forward by the Aboriginal Peak Organisations Northern Territory in May 2017. This should include reforming the program to move from a punitive, attendance-focused approach, towards one which rewards participation in activities that are selected and valued by the community and, in turn, provide skills and experiences, which improve the quality of life of all participants and their future employment prospects:
- (c) To inform the Prime Minister and the Leader of the Opposition of this resolution.

#### 19.3.13 FACILITATION GROUP

Rev David Fotheringham, Convenor of the Facilitation Group, presented feedback from the Voluntary Assisted Dying Response Working Groups session.

Dr Jessica Hateley-Browne, Project Officer, Voluntary Assisted Dying Reponse Report, responded to the feedback and spoke to a revised proposal.

## 19.3.14 WORKING GROUPS

The Synod met in working groups to discuss the revised Voluntary Assisted Dying Response proposals.

## 19.3.15 PRESBYTERIES EVENING PROGRAM

#### 19.4.11 CLOSE OF BALLOT (MAJORITY SUPPORT) SYNOD STANDING COMMITTEE

The Moderator declared the ballot closed at 3.42pm.

#### 19.4.12 NAIDOC WEEK ACTIVITY

Rev Will Pickett and Alison Overeem shared a National Aboriginal and Islander Day of Observance Committee (NAIDOC) week presentation on the NAIDOC theme of *Voice, Treaty and Truth* and the indigneous history, culture, achievements and walking together as first and second peoples.

#### 19.4.13 MINISTRY & MISSION COMMITTEE

#### 19.4.13.1 Statement from the Heart

Dr Mark Zirnsak, Senior Social Justice Advocate, eLM and Tim Molineux, Social Justice Officer, eLM spoke to a proposal.

- (a) To support the 2017 Statement from the Heart made at Uluru as a consensus position of 250 Aboriginal and Torres Strait Islander leaders from across Australia as the preferred pathway towards reconciliation, and urge the Commonwealth Government to implement:
  - The establishment of a First Nations Voice enshrined in the Constitution so that First Peoples have a greater say in policy and legislation which governs their affairs and, in so doing, improve their autonomy and prosperity;
  - (ii) The establishment of a *Makarrata* Commission to supervise a process of agreement-making between governments and First Nations, and provide a means for truth-telling about the history of Australia's First Peoples.
- (b) To commend the Statement from the Heart to congregations, presbyteries and agencies for prayerful engagement and discussion;
- (c) To advise the Prime Minister and the Leader of the Opposition of this Synod's resolution.

#### 19.4.13.2 Workers from the Pacific on Australian farms

Dr Mark Zirnsak, Senior Social Justice Advocate, eLM, spoke to a proposal.

The discussion was adjourned.

#### 19.4.14 ECUMENICAL AWARD

Rev Peter Weeks, Chairperson of the Ecumenical Relations Committee, spoke about the 2019 Ecumenical Award and announced that it has been awarded to the Kaniva Youth Group. The Kaniva Youth Group is led by members of the Serviceton Uniting Church in a shared ministry with the Kaniva Church of Christ. Activities offered are deliberately organised on an ecumenical basis and include involvement with Salvation Army, Lutheran, Catholic and Bordertown Highway Christian Chuurch young people. The group seeks to encourage youth in their Christian faith in a fun, safe environment, regardless of background. The Moderator, Rev Denise Liersch presented the award to Andrew Boatman, Chairperson, Prebytery of Western Victoria, who accepted on behalf of the Kaniva Youth Group.

The Moderator, Rev Denise Liersch announced that all nominees had gained majority support in the Synod Standing Committee Majority Support Ballot.

#### 19.4.16 TERMS OF PLACEMENT COMMITTEE

Rod Mummery, Chairperson, Terms of Placement Committee and Isabel Thomas Dobson, Secretary, Terms of Placement Committee, spoke to a proposal.

# 19.4.16.1 Stipends and Allowances

- (a) That the base level (2019 stipend) for stipends be \$60,159 pa;
- (b) That the adjustment/increase to the stipend for 2020 be 2.5%, for 2021 be 2.7% and for 2022 be 2.7%;

(c) That the base level for travel allowances for using private cars on professional duties by ministers in full-time or part-time placements be paid in two parts as follows:

#### Part 1: Car Allowance

- i. for travel up to 5,000 km per annum: \$5,300; or
- ii. for travel from 5,000 km up to 20,000 km per annum: \$5,300, plus \$330 per 1,000 km travelled above 5,000 km; or
- iii. for travel from 20,000 km up to 30,000 km per annum: \$10,250, plus \$200 per 1,000 km travelled above 20,000 km; or
- iv. for travel above 30,000 km per annum: \$12,250, plus \$130 per 1,000 km travelled above 30,000 km;

# Part 2: Fuel Cost Provision

The Fuel Cost Provision of \$200 per 1000 km of travel per annum.

- (d) That the ad hoc travelling allowances for minister's professional duties be:
  - 76.0 cents per kilometre for normal (average total) cost reimbursement for ministers not in placement, theological students and retired ministers; or
  - 40.0 cents per kilometre for marginal cost reimbursement only (which includes 20.0 cents per kilometre as the fuel cost component) for ministers in placement or other employment; and
  - iii. restricted, as a guideline, to a daily limit not exceeding reasonable commercial car rental costs.
- (e) That the base level for the manse allowance be \$18,266 per annum.

# 19.4.17.1 Response to Victorian Voluntary Assisted Dying Legislation

A revised Response to Victorian Voluntary Assisted Dying Legislation proposal was presented by the Facilitation Group who spoke to the suggested amendments.

Clauses (a)(i); (a)(ii); (a)(iv); (a)(vi) were resolved by consensus. See Minute 19.5.4.1 below.

The discussion was adjourned for further work to be coordinated by the Faciliatation Group on clauses (a)(iii) and (a)(v).

The Moderator, Rev Denise Liersch, thanked the theological reflection team. The Moderator presented a gift to each of the members of theological reflection team.

The Moderator's chaplain, Rev Paul Stephens closed the day in prayer.



#### 19.5 TUESDAY 9 JULY

The Moderator opened the session with an Acknowledgement of Country.

#### 19.5.1 DEVOTIONS

The Moderator's chaplains, Rev Paul Stephens and Jen Shields, led worship.

#### 19.5.2 BIBLE STUDY

Bible study was led by Dr Liz Boase on the theme of Directions - Looking Outwards (Ephesians 3:14-21).

The Moderator thanked Dr Liz Boase and presented her with a gift.

The Moderator thanked her chaplains Rev Paul Stephens and Jen Shields for their work and support during the Synod meeting and for leading devotions each day.

The Moderator also thanked the Theological Reflector Mentors Rev Robin Yang and Rev Dr Geoff Thompson for their mentorship prior to and over the course of the meeting.

## 19.5.3 BALLOT 2 - SYNOD STANDING COMMITTEE

The Returning Officer, Rod Mummery outlined the ballot process for members of Synod Standing Committee and confirmed that the ballot would close at 11.30am Tuesday 9 July 2019.

Ballot papers were distributed.

#### 19.5.4 FACILITATION GROUP

Rev David Fotheringham, Convenor of the Facilitation Group, presented revised clauses (a)(iii) and (a)(v) of the Response to Victorian Voluntary Assisted Dying Legislation proposal.

#### 19.5.4.1 PROCEDURAL RESOLUTION

After further plenary discussion the Moderator proposed the procedural proposal that the Synod needs to resolve the question now.

The Synod resolved by well over 75% majority to resolve the question now.

The Synod resolved that a threshold of a 66% majority would be required for any resolutions made under formal procedures.

#### 19.5.4.2 Response to Victorian Voluntary Assisted Dying Legislation

- (a) To affirm that:
  - (i) life is a gift of God, and all human life, regardless of circumstance, is precious to and has dignity before God;
  - (ii) neither death nor life, neither suffering nor anything else in all creation will be able to separate us from the love of God in Christ Jesus our Lord (see Romans 8:38-39);
  - (iii) as followers of Christ and through God's accompanying grace, fresh wisdom, peace and compassion can be birthed in the midst of suffering, which, without idolising suffering, is a deep and abiding mystery;

- (iv) while death is the end of mortal life it marks a new beginning in our relationship with God (see *Uniting in Worship 2:* Funeral Liturgy);
- (v) as followers of Christ we are called to spiritual discernment and responsibilty as we journey through life and death; and
- (vi) as the body of Christ we are called to be a loving and supportive community to people in need of care, including at the end of life.
- (b) To affirm that, in the light of (a) above, palliative care be the primary means through which end of life care is provided "for a person with an active, progressive, advanced disease, who has little or no prospect of cure and who is expected to die, and for whom the primary goal is to optimise the quality of life." (see Palliative Care Australia: palliative care definition).
- (c) To acknowledge that:
  - (i) it is a legal right, as of 19 June 2019, for all Victorians who meet the eligibility criteria and follow the process described in the Victorian Voluntary Assisted Dying Act 2017 to access voluntary assisted dying; and
  - (ii) most people will find palliative care and end of life services give them the support they need at the end of their life (see DHHS Fact Sheet on Understanding voluntary assisted dying).

The Synod resolved by formal majority:

- (d) To recognise that within the Synod:
  - (i) there is a range of faithful Christian responses to voluntary assisted dying which are consistent with the affirmations in clause (a); and
  - (ii) exploring, accessing, and conscientiously objecting to voluntary assisted dying are all within the range of faithful Christian responses to the Victoria Voluntary Assisted Dying Act 2017.
- (e) In the light of clauses (a), (b), (c) and (d) above, to give permission within Victoria to UCA institutions (Uniting VicTas and Uniting AgeWell) and the UCA-affiliated hospital group (Epworth HealthCare) to make voluntary assisted dying allowable within the context of their facilities and services for their patients, clients and residents, under the conditions described in the Victorian Voluntary Assisted Dying Act 2017.

- (f) To request that the relevant UCA institutions (Uniting VicTas and Uniting AgeWell) and the UCA-affiliated hospital group (Epworth HealthCare) in Victoria ensure they develop and adopt clear policies and procedures that allow staff and volunteers to conscientiously object to participating in voluntary assisted dying, in accordance with the provisions outlined in the relevant legislation.
- (g) To commit to the provision of a compassionate pastoral response to all people, including those who choose to explore or access voluntary assisted dying within Victoria and their families associated with the Church, and UCA institutions (Uniting VicTas and Uniting AgeWell) and the UCA-affiliated hospital group (Epworth HealthCare).
- (h) To request the equipping Leadership for Mission (eLM), in collaboration with the Synod Ethics Committee, to resource UCA ministers, lay leaders, chaplains, pastoral care workers and other who offer spiritual and pastoral support to people

(and their families) who are exploring, accessing, or who have accessed voluntary assisted dying, including taking into account:

- (i) engagement with First Peoples;
- (ii) diverse cultural and languages needs;
- (iii) the range of faithful Christian responses; and
- (iv) the need for prayers and liturgical support for pastoral care and funerals, in consultation with the Assembly's Transforming Worship Panel.
- (i) To write to the Victorian Premier and relevant government ministers:
  - to call on the Victorian Government to increase resourcing for palliative care as the primary means through which end of life care is offered and delivered; and
  - (ii) to encourage the Victorian Government to engage with First Peoples and culturally and linguistically diverse communities in resourcing the understanding of the Victorian Voluntary Assisted Dying Act 2017.
- (j) To advise the Leader of the Opposition and shadow spokespeople of the action in (i) above.

The Moderator thanked the Facilitation Group members for their work throughout the Synod meeting on this matter, and Dr Jessica Hateley-Browne for her assistance and work on the Voluntary Assisted Dying Response Project.

The Moderator advised that she will issue a pastoral letter communicating the resolution Response to Victorian Voluntary Assisted Dying Legislation and the unconfirmed minute will be published on the Syond App and available for distribution.

- (b) To call on the Commonwealth Government to increase the number of people from the Pacific able to work under the Seasonal Worker Program and the Pacific Labour Scheme, provided that adequate safeguards are in place to prevent exploitation of people on these schemes, and to ensure their well-being;
- (c) To call on the Commonwealth Government to use the Seasonal Worker Program and the Pacific Labour Scheme to provide people to work in rural Australia, in preference to;
  - (i) a new agricultural visa that lacks the safeguards of these schemes; and
  - (ii) providing further incentives for people on working holiday visas to put up with exploitation and abuse to obtain an extension to their visa;
- (d) To inform the Prime Minister, the Leader of the Opposition and relevant Ministers and Shadow Ministers of this resolution.

#### 19.5.6 PROPOSAL FROM MEMBERS



The Moderator spoke to a report which was received with acclamation.

# 19.2.10.1 Minute of Appreciation: Rev Sharon Hollis

The Synod resolved by acclamation:

To record its appreciation for the ministry of Rev Sharon Hollis as Moderator of the Synod of Victoria and Tasmania from 3 June 2016 to 5 July 2019; and

To give thanks to God for Sharon's faithful sharing of her many gifts in service to the Church and to the wider community, including her gracious, courageous and compassionate leadership in living out Jesus Christ's call to follow him and participate in his ministry of reconciliation and renewal.

Sharon's pastoral heart shines through all the work she has undertaken. She has shown the depth of her concern for people and their wellbeing wherever she meets them in her extensive travels across Victoria and Tasmania or in difficult situations arising in the life of our Church. She has encouraged reflection and held space for prayer and lament, taking time to build relationships as she journeys with individuals and their communities in both their joys and sorrows.

Sharon has brought her whole self to the role of Moderator and her whole life to her ministry including her experiences of love and loss. She has not shied away from allowing us glimpses of her vulnerable self, especially in her commitment to supporting mental health awareness and destigmatising mental illness and suicide.

Sharon has been an excellent chairperson of Synod Standing Committee, and various other committees and groupings. She is diligent and thorough in her preparation, and plans the shape of the meeting looking for the best outcomes for peoples' time. She has been non-reactive and worked with focus and intention. The strength of her ability to facilitate discernment is attested to by members of committees and groups throughout the Church.

Sharon has shared her focused and creative leadership as the Synod implements the outcomes of the Major Strategic Review. Her contribution to this process has been cuttingedge, provoking us to think in new ways about our life as the Church. She brings the Synod Vision and Mission Principles to life by sharing her conviction in their importance for shaping our life together.

Sharon has generously shared her passion for the particularities of how we understand ourselves and order our ministry and mission as the Uniting Church in Victoria and Tasmania. She has expressed this through her commitment to our walking together as First and Second Peoples, ecumenical and interfaith dialogue, her work with the Victorian Government's Multi Faith Advisory Group and our shared discernment of areas in the Church where we require reform. Her public leadership in the wider community, and indeed throughout the Church, has been deeply valued by the many organisations with which she has engaged, including U Ethical, Uniting AgeWell, Uniting VicTas, Uniting Housing, and the UCA associated Schools and University Colleges.

Sharon has advocated boldly for justice in the Church and the wider community. She has listened compassionately to people's sharing of their experiences of injustice and has stood alongside them to speak and act prophetically. Sharon has spurred us on to pay greater attention to systemic inequality and to respond by living out the call to renewal in the power and hope of Christ. By readily calling out the state of affairs with grace and, as required, great humour, Sharon has comforted many and encouraged them as they persevere in making their witness heard.

We give thanks for Sharon's faithful service as Moderator and for her continuing devotion to Christ, her ministry and her leadership that has challenged and encouraged us to remember that Christ constitutes, rules and renews his disciples as his Church.

(d) To request all presbyteries to work towards 30% of elected members to the next Synod being under the age of 50;

- (e) To invite all congregations and presbyteries to commit to, and action, this resolution;
- (f) To invite Assembly to partner with the Synod of Victoria and Tasmania in addressing this issue nationally.

#### 19.3.12.2 Reform of the Community Development Program

- (a) To acknowledge the discriminatory nature of the Community Development Program, which sees higher requirements placed mainly on First Australians seeking employment in remote areas than on people elsewhere in Australia;
- (b) To call on the Commonwealth Government to work with First People organisations to develop a new program to assist First People, in remote Australia who are looking for work, such as the proposal put forward by the Aboriginal Peak Organisations Northern Territory in May 2017. This should include reforming the program to move from a punitive, attendance-focused approach, towards one which rewards participation in activities that are selected and valued by the community and, in turn,

- provide skills and experiences, which improve the quality of life of all participants and their future employment prospects;
- (c) To inform the Prime Minister and the Leader of the Opposition of this resolution.

## 19.3.12.1 Safeguarding for People with Disabilities

The Synod resolved by consensus:

- (a) To call on the Commonwealth Government to safeguard the safety and wellbeing of people living with disability by:
  - (i) ensuring that the NDIS Quality and Safeguards Commission has sufficient jurisdiction and resources to provide thorough oversight and regulation of disability and mental health services operating under the NDIS to prevent abuse, neglect and other mistreatment of people with disabilities. While these safeguards must prioritise the health and safety of people with disability, the approach should be designed to minimise unnecessary regulatory burden experienced by providers;
  - (ii) providing a dedicated team of staff within the NDIS Quality and Safeguards Commission to investigate preventable deaths that occur when people with disabilities are in the care of service providers within the NDIS;
  - (iii) putting in place robust systems to screen all individuals that provide services to people with disabilities under the NDIS;
  - (iv) maintaining and enhancing Community Visitors' and Official Visitors' programs, across states, to provide a vital monitoring and advocacy role for people with disabilities.
- (b) To write to the Prime Minister and the Leader of the Opposition to inform them of this resolution.

#### 19.4.13.1 Statement from the Heart

- (a) To support the 2017 Statement from the Heart made at Uluru as a consensus position of 250 Aboriginal and Torres Strait Islander leaders from across Australia as the preferred pathway towards reconciliation, and urge the Commonwealth Government to implement:
  - (i) The establishment of a First Nations Voice enshrined in the Constitution so that First Peoples have a greater say in policy and legislation which governs their affairs and, in so doing, improve their autonomy and prosperity;
  - (ii) The establishment of a *Makarrata* Commission to supervise a process of agreement-making between governments and First Nations, and provide a means for truth-telling about the history of Australia's First Peoples.
- (b) To commend the Statement from the Heart to congregations, presbyteries and agencies for prayerful engagement and discussion;
- (c) To advise the Prime Minister and the Leader of the Opposition of this Synod's resolution.

#### 19.5.6.1 Workers from the Pacific on Australian farms

- (a) To acknowledge that the problem of high levels of unemployment in Pacific Island countries means that temporarily working overseas is a key pathway out of poverty for many;
- (b) To call on the Commonwealth Government to increase the number of people from the Pacific able to work under the Seasonal Worker Program and the Pacific Labour Scheme, provided that adequate safeguards are in place to prevent exploitation of people on these schemes, and to ensure their well-being;
- (c) To call on the Commonwealth Government to use the Seasonal Worker Program and the Pacific Labour Scheme to provide people to work in rural Australia, in preference to;
  - (i) a new agricultural visa that lacks the safeguards of these schemes; and
  - (ii) providing further incentives for people on working holiday visas to put up with exploitation and abuse to obtain an extension to their visa;
- (d) To inform the Prime Minister, the Leader of the Opposition and relevant Ministers and Shadow Ministers of this resolution.

# 19.5.4.2 Response to Victorian Voluntary Assisted Dying Legislation

- (a) To affirm that:
  - (i) life is a gift of God, and all human life, regardless of circumstance, is precious to and has dignity before God;
  - (ii) neither death nor life, neither suffering nor anything else in all creation will be able to separate us from the love of God in Christ Jesus our Lord (see Romans 8:38-39);
  - (iii) as followers of Christ and through God's accompanying grace, fresh wisdom, peace and compassion can be birthed in the midst of suffering, which, without idolising suffering, is a deep and abiding mystery;
  - (iv) while death is the end of mortal life it marks a new beginning in our relationship with God (see *Uniting in Worship 2:* Funeral Liturgy);
  - (v) as followers of Christ we are called to spiritual discernment and responsibility as we journey through life and death; and
  - (vi) as the body of Christ we are called to be a loving and supportive community to people in need of care, including at the end of life.

- (b) To affirm that, in the light of (a) above, palliative care be the primary means through which end of life care is provided "for a person with an active, progressive, advanced disease, who has little or no prospect of cure and who is expected to die, and for whom the primary goal is to optimise the quality of life." (see Palliative Care Australia: palliative care definition).
- (c) To acknowledge that:
  - it is a legal right, as of 19 June 2019, for all Victorians who meet the eligibility criteria and follow the process described in the Victorian Voluntary Assisted Dying Act 2017 to access voluntary assisted dying; and
  - (ii) most people will find palliative care and end of life services give them the support they need at the end of their life (see DHHS Fact Sheet on Understanding voluntary assisted dying).

The Synod resolved by formal majority:

- (d) To recognise that within the Synod:
  - (i) there is a range of faithful Christian responses to voluntary assisted dying which are consistent with the affirmations in clause (a); and
  - (ii) exploring, accessing, and conscientiously objecting to voluntary assisted dying are all within the range of faithful Christian responses to the Victoria Voluntary Assisted Dying Act 2017.
- (e) In the light of clauses (a), (b), (c) and (d) above, to give permission within Victoria to UCA institutions (Uniting VicTas and Uniting AgeWell) and the UCA-affiliated hospital group (Epworth HealthCare) to make voluntary assisted dying allowable within the context of their facilities and services for their patients, clients and residents, under the conditions described in the Victorian Voluntary Assisted Dying Act 2017.

- (f) To request that the relevant UCA institutions (Uniting VicTas and Uniting AgeWell) and the UCA-affiliated hospital group (Epworth HealthCare) in Victoria ensure they develop and adopt clear policies and procedures that allow staff and volunteers to conscientiously object to participating in voluntary assisted dying, in accordance with the provisions outlined in the relevant legislation.
- (g) To commit to the provision of a compassionate pastoral response to all people, including those who choose to explore or access voluntary assisted dying within Victoria and their families associated with the Church, and UCA institutions (Uniting VicTas and Uniting AgeWell) and the UCA-affiliated hospital group (Epworth HealthCare).
- (h) To request the equipping Leadership for Mission (eLM), in collaboration with the Synod Ethics Committee, to resource UCA ministers, lay leaders, chaplains, pastoral care workers and other who offer spiritual and pastoral support to people (and their families) who are exploring, accessing, or who have accessed voluntary assisted dying, including taking into account:
  - (i) engagement with First Peoples;
  - (ii) diverse cultural and languages needs;
  - (iii) the range of faithful Christian responses; and

- (iv) the need for prayers and liturgical support for pastoral care and funerals, in consultation with the Assembly's Transforming Worship Panel.
- (i) To write to the Victorian Premier and relevant government ministers:
  - to call on the Victorian Government to increase resourcing for palliative care as the primary means through which end of life care is offered and delivered; and
  - (ii) to encourage the Victorian Government to engage with First Peoples and culturally and linguistically diverse communities in resourcing the understanding of the Victorian Voluntary Assisted Dying Act 2017.
- (j) To advise the Leader of the Opposition and shadow spokespeople of the action in (i) above.

- (d) That the base level for travel allowances for using private cars on professional duties by ministers in full-time or part-time placements be paid in two parts as follows:

#### Part 1: Car Allowance

- i. for travel up to 5,000 km per annum: \$5,300; or
- ii. for travel from 5,000 km up to 20,000 km per annum: \$5,300, plus \$330 per 1,000 km travelled above 5,000 km; or
- iii. for travel from 20,000 km up to 30,000 km per annum: \$10,250, plus \$200 per 1,000 km travelled above 20,000 km; or
- iv. for travel above 30,000 km per annum: \$12,250, plus \$130 per 1,000 km travelled above 30,000 km;

#### Part 2: Fuel Cost Provision

The Fuel Cost Provision of \$200 per 1000 km of travel per annum.

- (e) That the ad hoc travelling allowances for minister's professional duties be:
  - 76.0 cents per kilometre for normal (average total) cost reimbursement for ministers not in placement, theological students and retired ministers; or
  - 40.0 cents per kilometre for marginal cost reimbursement only (which includes 20.0 cents per kilometre as the fuel cost component) for ministers in placement or other employment; and
  - restricted, as a guideline, to a daily limit not exceeding reasonable commercial car rental costs.
- (f) That the base level for the manse allowance be \$18,266 per annum.
