# Terms and Conditions

## 1. Introduction

- 1.1 By subscribing to or accessing **any of our newsletters or email communications**, you agree to be bound by these Terms and Conditions ("Terms"). ## 2. Subscription and Consent

## 3. Privacy

- 3.1 Your privacy is important to us. We may collect, use, and disclose your personal information in accordance with our Privacy Policy and relevant Australian laws, including the *Privacy Act* 1988 (Cth) and the Australian Privacy Principles (APPs). This section outlines how we handle your personal information:



- (a) **Data Collection:** We collect personal information, such as your name and email address, when you subscribe to our newsletters. Additional information may be collected if necessary to provide services or respond to your enquiries. If you do not provide this information, you will not receive (and may not be able to access) our newsletters and other relevant communications from us, and we may not be able to provide you with the services you need from us or respond to your enquiries.
- (b) **Data Use and Disclosure:** The personal information you provide is used to deliver the newsletters and related communications, including updates, events, and promotional materials that may interest you. We may share your personal information with trusted third-party service providers, such as mailing platforms, who help us deliver these communications.
- (c) **Data Security:** We take reasonable steps to protect your personal information from misuse, interference and loss, and from unauthorised access, modification or disclosure.
- (d) **Access, Correction, and Complaints:** You have the right to request access to, correction of, or deletion of your personal information at any time.
